Re: Recent Excessive Deaths in Irish Nursing Homes

Dear Professor Butler,

I am contacting you as the independent expert group that provides evidence-based advice to the Department of Health and Chief Medical Officer on vaccines, immunisation and related health matters to inform health policies in Ireland. Ms. Mary Dickinson of The Coroner Service Implementation Team, Department of Justice has advised me to contact you. The Taoiseach, Minister for Health, HSE, HIQA, HPRA all TD's and Senators have been notified of the situation but have failed to engage.

I wish to make you aware of a very serious rise in the number of nursing home deaths (excess deaths) for the three-week period beginning at the end January 2021. The attached chart (page 3) shows 160 deaths from a selection of just 10 of the 572 HIQA registered nursing homes that I have studied during the period mentioned. In comparison there were only a small number of deaths in those same nursing homes during December 2020 and January 2021. Considering the overall reduction in COVID-19 related deaths, hospitalisations and positive PCR tests for the same period, the dramatic rise in deaths gives me great cause for concern. Please refer to the attached graph on page 4 showing data for these key trends.

While this sudden unexplained rise in nursing home deaths may be due to a number of factors, I found that the majority of these excess deaths occurred directly after the rollout of the COVID-19 vaccination programme for nursing homes and may indicate a serious adverse drug reaction to the vaccine. If an adverse reaction to the vaccinations has contributed to these deaths, it has the potential to adversely affect the health of all European citizens due to the planned ongoing rollout to every citizen.

I am attaching tables detailing 97 deaths in five of the Nursing homes that I have studied in more detail as follows: -

1. Blackrock Abbey - ACH Nursing Home and Healthcare Ltd. Cockle Hill,
Blackrock, Dundalk, Co. Louth, A91 RP76.

2. Carechoice Ballynoe Limited, Whites Cross, Co. Cork, T23 VH39.
3. Beech Park Nursing Home - Dunmurry West Care Homes Ltd, Dunmurry East, Kildare Town, Co. Kildare, R51 PC58
4. Lucan Lodge Nursing Home, Passage Healthcare International (Ireland) Limited, Ardeevin Drive, Lucan , Co. Dublin, K78Y192
5. St. Michael's Nursing Home - Blockstar Ltd., One Hundred Acres East, Caherconlish, Co. Limerick, V94 E400

I obtained this information from studying RIP.ie death notices and I am also attaching copies of 42 Death Records which have been registered in the GRO for some of the deaths thus far. One serious point of concern that I have regarding the causes of death on these death records is that the majority of the deceased suffered from combinations of Alzheimer's, Dementia and Cognitive Disorders and would not have been in a position to protect themselves during a period when their relatives were preventing from visiting them under the COVID-19 restrictions and unable to monitor their care and treatment before the deaths.

I feel a moral obligation to report these excess deaths to you and recommend an immediate suspension of the European COVID-19 vaccination programme rollout as a precautionary measure. The high numbers of recent deaths in nursing homes must be fully investigated and explained to ensure that the vaccinations are not contributing to the recent excessive number of deaths.

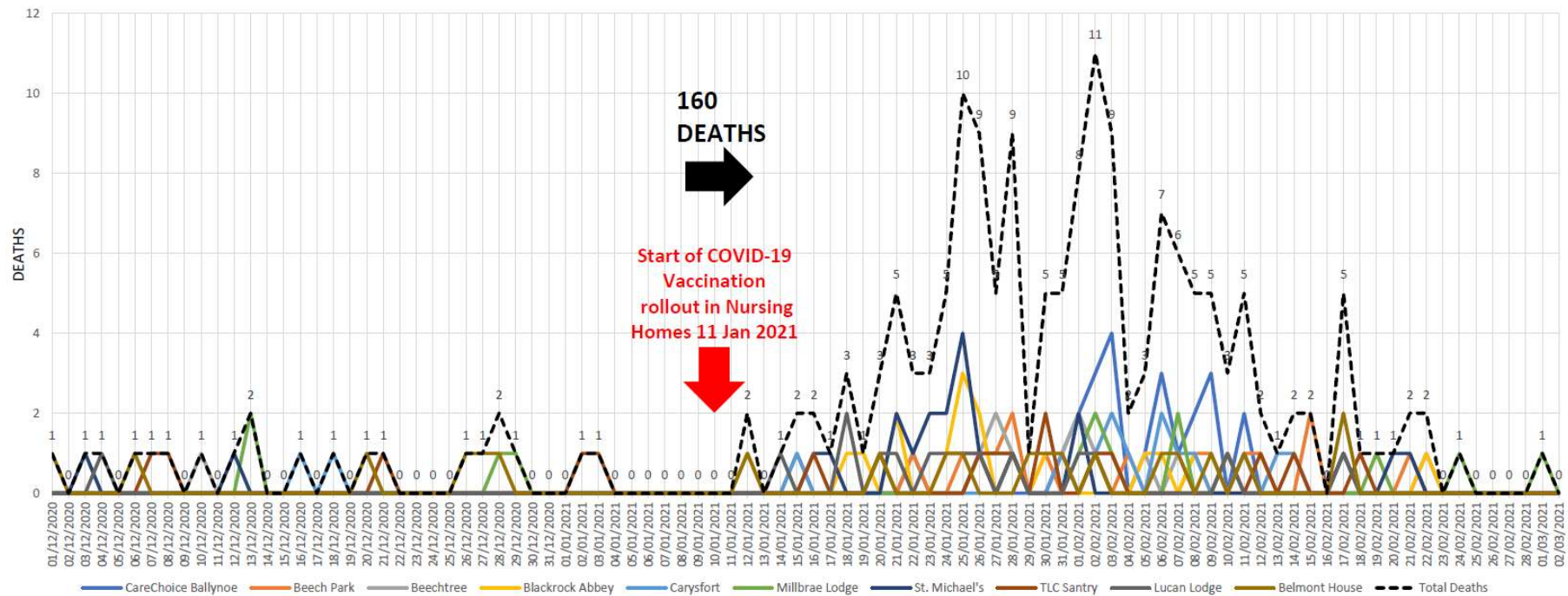

I eagerly await your response to this developing situation which is urgent as similar groups of suspicious deaths are showing up in Nursing Homes on RIP.ie regularly.

DEATHS from 1st Dec to 2020 to 2nd Mar 2021 in 10 Selected Irish Nursing Homes - source RIP.ie

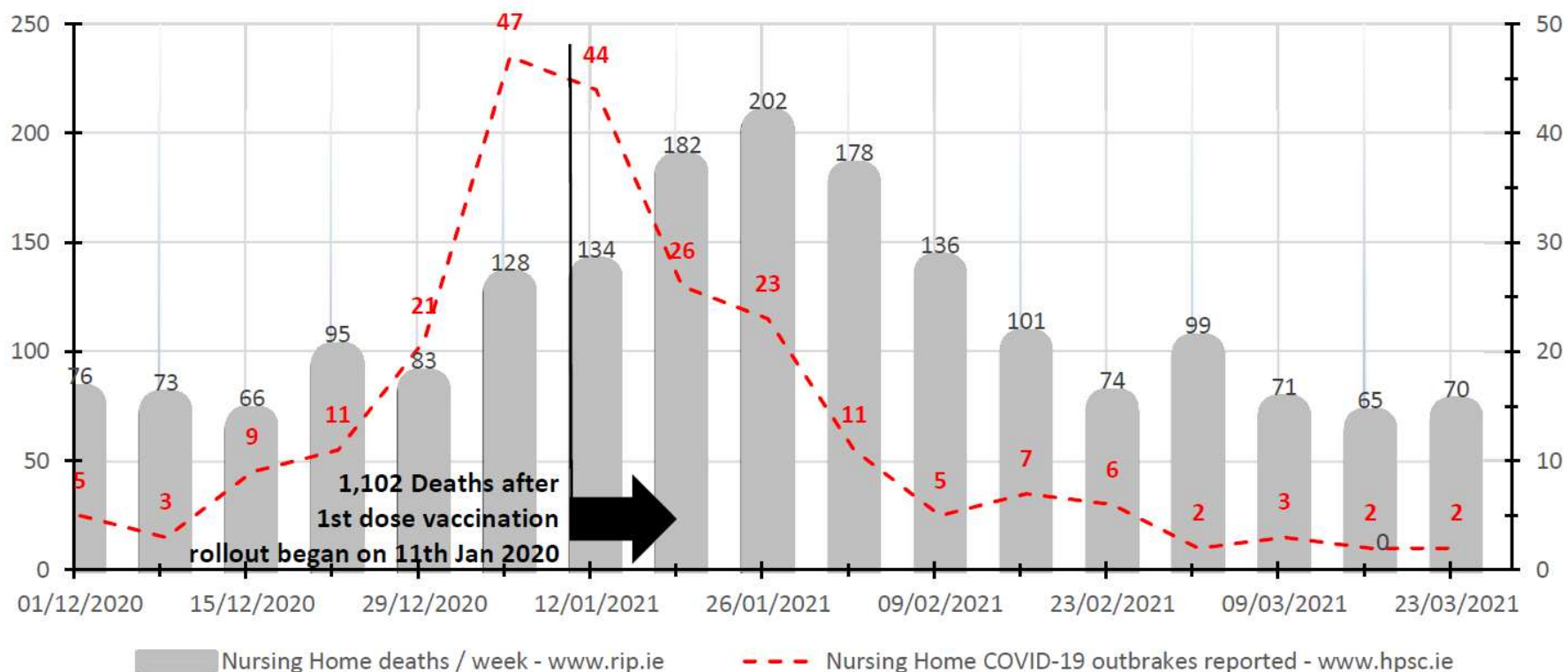


COVID-19 Key Trends - Ireland Dec 2020- Feb 2021 - Data from data.gov.ie



Deaths identified in the 572 HIQA Registered Nursing Homes in Ireland

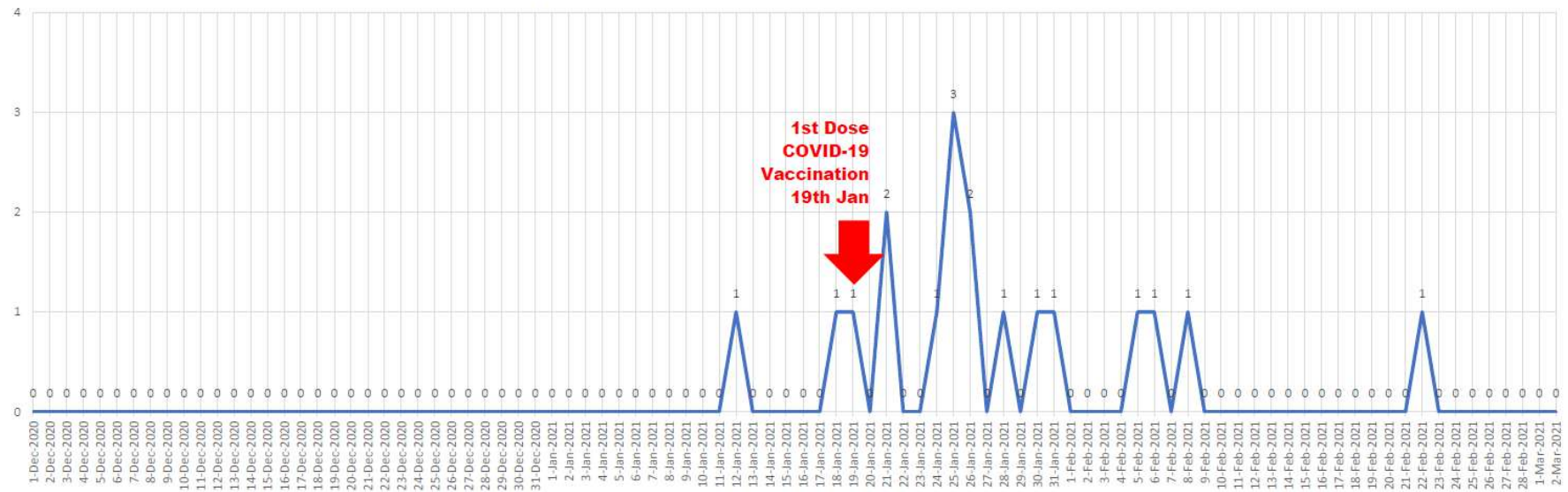

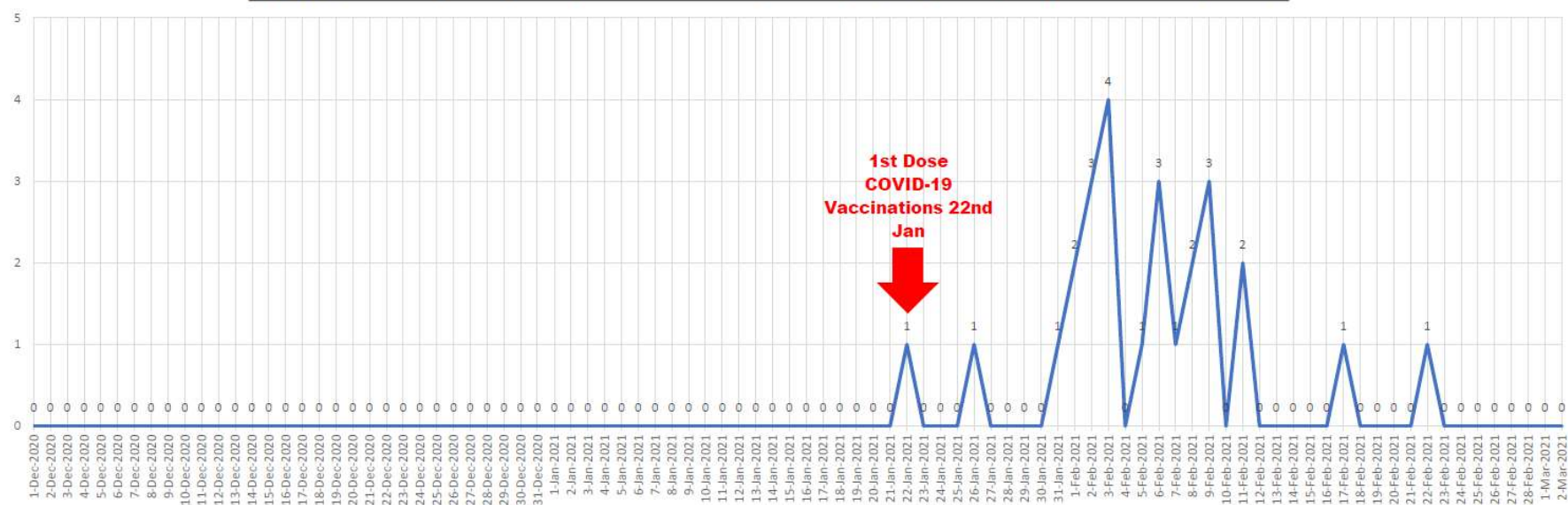

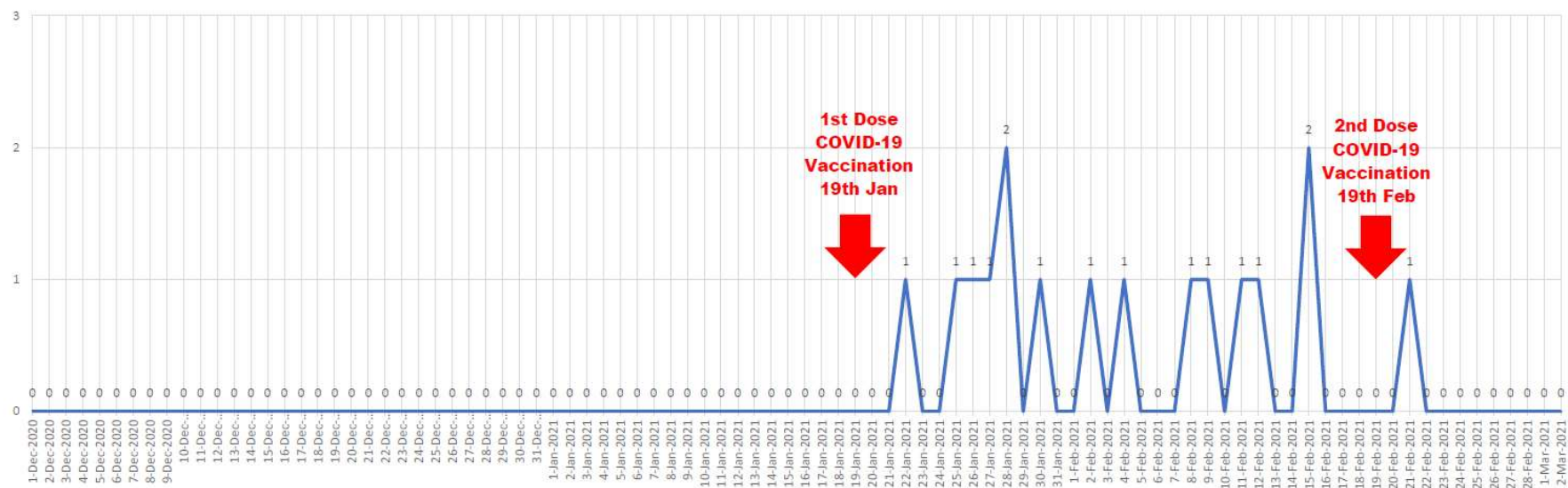

Beech Park Nursing Home, Kildare - 16 DEATHS from 1st Dec, 2020 to 2nd Mar, 2021

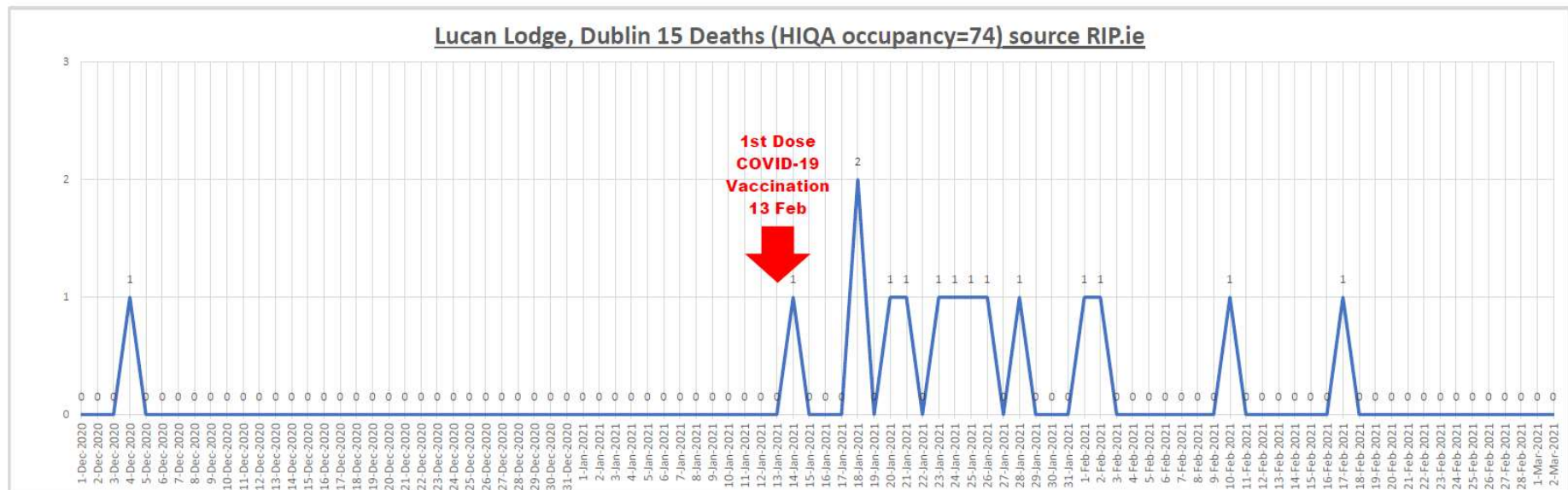
